DESCRIPTION

KingProof B50 is a black/brown emulsified bitumen liquid reinforced with latex rubber, acting as damp-proof, vapour barrier and protective coating for concrete and masonry.

APPLICATIONS

KingProof B50 provides a vapour barrier, protective coating, and curing compound for:

- ☐ Underground concrete foundations.
- ☐ Concrete and masonry block walls.
- ☐ Walls behind cladding systems.
- ☐ Concrete slabs.
- ☐ Basement walls.

STANDARDS

KingProof B50 complies with ASTM D1227-95, Type II, Class 2.

KingProof B50 complies with ASTM C309-93 when applied with two coats at a rate of 2 m²/litre.

METHOD OF USE

Surface Preparation

Surface preparation is very important to get the highest performance of KingProof B50. Any surface to be coated must be clean, sound and free of oil or grease. Any oil or grease contamination should be removed with a chemical degreaser.

All holes should be filled with a suitable cementitious mortar before application of KingProof B50.

Primer Coat

There is generally no need for primer coat. Dusty surfaces should be primed with a coat of KingProof B50, diluted with an equal quantity of cool, clean water and allowed to dry.

APPLICATION

It is recommended that two coats of KingProof B50 be applied. The second coat should be applied at right angle to the first coat. Allow a minimum of 2 hours between coats. Stir well before use. KingProof B50 may be applied by brush, broom or squeegee.

COVERAGE

3 - 5 m²/litre, depending on surface roughness.

CLEANING

Tools and equipment can be cleaned with water when still wet.

Dried KingProof B50 may be removed with KINGKRETE Solvent.

PACKAGING

KingProof B50 is available in 18 and 200 litre drums.

STORAGE

Shelf life is 1 year when stored under cover, out of direct sunlight and protected from extremes of temperature.

Failure to comply with the recommended storage conditions may result in premature deterioration of the product or packaging. For specific storage advice consult KingKrete's Technical Services Department.

HEALTH AND SAFETY

As with all chemical products, care should be taken during use and storage to avoid contact with eyes, mouth, skin and foodstuffs. Treat splashes to eyes and skin immediately. If accidentally ingested, seek medical attention. Reseal containers after use. Use in well ventilated areas and avoid inhalation.
